TERMS AND CONDITIONS OF WARRANTY

(Applies to autolock AV2 Heritage Automatic Locking System manufactured as from 1ST January 2013

- 1. All moving parts and hooks, latch and deadbolt must be lubricated at least once a year using a silicon spray or similar.
- Winkhaus should be consulted first if it is intended to install the lock in humid rooms/conditions or in areas with aggressive/corrosive environment or within any door that is constructed of material that may cause corrosion to the lock.
- 3. All components must be fitted in accordance with Winkhaus mounting instructions.
- 4. The lock must be regularly checked for wear and tear and if necessary fixing screws should be tightened and /or parts replaced.
- 5. Only non corrosive cleaners should be used on Doors and care should be taken to ensure that any cleaning substances do not come into contact with the Lock or keeps.
- 6. If Doors are to be surface treated (such as preservative spray, paint or stain) or coated with any type of substance then the Lock and keeps must be protected from contamination and should not come into contact with the surface treatment until dry.
- 7. Any adjustment of the Keeps must be carried out by skilled personnel. This also applies to the initial installation and adjustment of the Door and any subsequent replacement of parts.
- 8. The Warranty is only applicable if all <u>parts</u> used are original Winkhaus components and mounting has been carried out in accordance with our instructions.
- The Warranty will not apply in respect of any mechanical breakdown which results wholly or partly from :
 - a) Any collision, impact, accident, fire, self ignition or explosion, theft or attempted theft, frost, freak weather or temperature conditions.
 - b) Any deliberate damage, neglect or misuse of the Lock or keeps or any modification such as fitting of replacement or experimental parts or other equipment not approved by Winkhaus.
 - c) A gradual reduction in operating performance of any component where this can reasonably be considered to be the result of general wear, tear and deterioration commensurate with age or use of the Lock.
- 10. The Warranty does not apply to any other costs involved with fitting replacement parts/ or Door which maybe incurred by the original Door manufacturer or any other third party, whatsoever. Dependent on the cause of failure and the circumstances involved and at the discretion of Winkhaus, consideration maybe given to reimbursing the onsite labour costs only in fitting a replacement lock or component.
- 11. The warranty does not apply to any third party ancillary actuation devices, Access control systems or power supply units that maybe connected to this locking system.

Should any defects occur within the 10 year warranty period (From the date the Lock and keeps were supplied to the Door manufacturer) which are due to incorrect manufacture of the lock, or the material used for manufacture being not to specification, then Winkhaus will supply replacement parts, free of charge, to the original Door manufacturer or supplier. This is subject to the defective parts being returned to Winkhaus at no cost.
